Statement according to the legislation on privacy

Legislative Decree 196/03 – EU Regulation 679/2016 – Legislative Decree 101/18 - Contractors

Weiss Technik Italia S.r.l., with registered office in Magenta (Mi), via Romolo Murri 22/28, as Data Controller, informs all suppliers, contractors, pursuant to art.13 of EU Reg. n. 679/2016, that the processing of personal data will be based on principles of correctness, lawfulness, transparency and protection of confidentiality.

Legal basis of the treatment is the contract with Weiss Technik Italia S.r.l. The information you provide will be used for the execution of the same and for the fulfillment of related legal obligations, including tax or accounting, or for any defense purposes in court.

Weiss Technik Italia S.r.l. will only process certain categories of personal data, such as personal data, professional data, data concerning physical fitness and certification required by law. The processing of such information is strictly necessary to execute the contract and does not require any consent.

The contractor will take care to inform its staff:

- a) that in order to manage technical - commercial proposals, participate in tenders, perform pre-contractual and contractual obligations with customers and companies in partnership, the data concerning the contractor and its staff, also related to the physical fitness of its staff (if the acquisition of the latter is necessary for the evaluation of the activity to be carried out) may be made available to other companies operating abroad. The transfer of information strictly necessary for the above-mentioned pre-contractual and contractual purposes will take place in compliance with the principles and conditions of legitimacy established by EU Regulation 2016/679.
- b) that in order to access the Owner's premises/facilities and/or on behalf of the Owner, data processing limited to the collection and management of data of the aforesaid personnel strictly necessary to implement the regulatory provisions on health and safety in the workplace (Legislative Decree 81/2008 and similar foreign regulations) related to the management of contracts and interference risks will take place.

The Owner's internal procedures provide that personal data - managed by the Company's personnel in accordance with specific privacy instructions - are collected in paper and computer files and processed in the manner strictly necessary for the purposes indicated. The personal data of each supplier, contractor, sub-contractor will neither be disclosed nor communicated to third parties, and will be kept for the entire duration of the contractual relationship plus any period of historical storage required by law.

In accordance with art. 15 and following of EU Regulation 679/2016, each interested party has the right to know, at any time, what his data are and how they are used. He also has the right to have them updated, supplemented, corrected or deleted, to request their blocking and to object in whole or in part to their processing, even in relation to only one of the purposes or methods listed above, by writing to the following e-mail address info.it@weiss-technik.com.

Should the data subject find a violation of his/her rights, he/she may contact the competent supervisory authority pursuant to art. 77 of EU Regulation no. 679/2016. This is without prejudice to the possibility of contacting the judicial authority directly.
